

Posting to The Love Consortium Dataverse

Step-by-step guide and examples

Overview

This document details the submission process to The Love Consortium Dataverse. The process involves 6 steps, only 4 of which are required:

1. Create an account (~2 minutes)
2. Create a record within The Love Consortium Dataverse (~1 minute)
3. Describe your data so others can find it (15 - 30 minutes)
4. (Optional) Upload supplementary files
5. Review your record (~5 minutes)
6. (Optional) Connect your Open Science Framework account to The Love Consortium Dataverse

Altogether, the upload process will take between 30 minutes and an hour, depending on how detailed you choose to be in your description of the dataset and how many supplemental files you wish you upload. Additional resources can be found on our website:

Step 1: Create an account

To set up an account, go to <https://dataverse.unc.edu/dataverse/love> and click **Log In** in the upper right corner.

Select your institution from the drop-down menu to create an account using your institution's login service.

If your institution is not in the drop-down, please select **Sign Up** and fill in the form to create your free account.



Step 2: Create a record



Step 3: Describe your data

The Love Consortium Submission Template contains a number of required and optional fields to help you describe your dataset and, in turn, help others find it.

Take some time to **complete the required (*) fields as well as any optional fields** you think are useful. The fields with checklist responses (e.g., “Commonly Used Love Assessment” and “Commonly Studied Constructs”) are especially helpful for search visibility, so take the extra time to go through the full list of options.

Use the open-text boxes (e.g., “Notes” and “Description”) to highlight any additional constructs or methods used which are not already captured in the other fields.

Slides 11-14 in the appendix provide examples of three datasets currently included in The Love Consortium Dataverse with varied methods and sample characteristics.

Step 4: (Optional) Upload supplementary files

You may also upload supplementary documents (e.g., codebooks, detailed procedural information, data files) with your record.


Any data files must be de-identified and stripped of sensitive variables and you must also have permission to share the data (i.e., IRB approved and not proprietary). Data files should be saved in one of the following formats for the best preservation:

- SPSS - Versions 7 to 22 (.por OR .sav)
- Stata - Versions 4 to 13 (.dta)
- R – Versions 1 to 3 (.RData)
- Microsoft Excel (.xlsx)

All other files (e.g., codebooks) should be saved as PDF or TXT files. Be sure to include the title of your study, author(s) name(s), and contact information on all pages of your document.

When you're ready to upload a file, click **+Select Files to Add** and locate the file on your computer.

Edit the **File Name** and add a **Description**.



Step 4: (Optional) Upload supplementary files

If you want users to have to request access from you before downloading a file, select the checkbox next the file, followed by **Edit > Restrict**. This will trigger an email to be sent to you whenever a user requests your file.

Restricted files are denoted by a green lock symbol.

Unrestrict a file by selecting the checkbox next to the file, then **Edit > Unrestrict**.

Once all files are uploaded, click **Save Dataset**

Step 5: Review your record

Review your record once more before submitting.

If any changes need to be made, select **Edit > Metadata** in the upper right corner of the record.*

Once edits are completed, click **Save Changes**.


Review *Terms of Use* by selecting **Edit > Terms**.

Make any edits and click **Save Changes**.

When you're ready to submit your record, click **Submit for Review**.

A member of the administrative team will review your record for clarity, ask any additional questions, and publish your record when ready.

**Note: Editing the metadata will provide access to more fields than are visible in The Love Consortium Template. Although not necessary, you are welcome to provide additional information in those fields if you'd like.*

Description ?	<p>80 romantic couples (N = 160) from Chapel Hill, North Carolina and the surrounding region (e.g., Durham, NC; U. S. A.) enrolled in a two week observational study. 88 people from 55 couples also completed an unplanned follow-up survey in response to an email sent approximately six months after study completion.</p> <p>To be eligible, they must have been at least 18 years old and in a romantic relationship for a minimum of 6 months.</p> <p>On average, participants were in their late 20s (range 18-57), had been involved in their romantic relationship for just more than four years, and the majority identified as White/Caucasian (74.4%). 77 of the 80 couples were heterosexual.</p> <p>Participants independently completed a 45-minute online questionnaire in the days prior to their first lab session. There, baseline psychophysiology was again assessed, they participated in two structured videorecorded conversations in which one member of the couple expressed gratitude to the other and privately answered questionnaires after each conversation. Psychophysiology was assessed during these conversations. Description

We conducted an Ecological Momentary Assessment (EMA; or experience sampling) studies to examine the within-person processes in experienced love in daily life and how these processes relate to person characteristics. This study was conducted at the Pennsylvania State University. The study procedure along with the sample characteristics is as follows:

SAMPLE. This EMA study consisted of 52 individuals (17 male and 35 female, mean age = 30 years, SD = 10, min = 19, max = 48). This sample consisted of students and university staff of the Pennsylvania State University and data collection occurred during the summer of 2016. We refer to this sample as the Community Sample due to the diversity in age range in our participants.

PROCEDURE. This study was a four-week long EMA study. The day before the EMA procedure began, in the introductory session, the participants completed a battery of self-report surveys (BFI-2, Flourishing, Health, General Happiness, Gratitude, Satisfaction With Life, Meaning in Life, Authentic Happiness, PERMA Profiler) and demographics items. They then provided informed consent and their respective phone numbers were registered with the text messaging service SurveySignal (SurveySignal, LLC, 2015). Text messages to complete the EMA surveys were sent to the participants' smartphones six times a day. Survey timing was determined by dividing participants' self-reported usual waking hours into six equal-length intervals, and survey prompts were delivered at a random timing within each time interval, constrained so that no two prompts were less than 30 minutes apart. This sampling scheme was chosen to reduce expectation biases in reporting while providing a representative sampling of the individuals' context. Web-based EMA surveys were designed in and delivered by the Qualtrics survey system (Qualtrics, Provo, UT, 2017). Over the course of the four weeks, participants received and responded to up to 168 text-message (six per day) prompted web-based EMA surveys. Each EMA survey contained 10-12 questions/statements, three of which were centered on loving feelings ("How much do you feel loved right now?", "I love the world around me.", "Since the last survey, I have been expressing love."). Additional items were related to elements of well-being. After the four-week EMA data collection, in an Exit session, participants returned to the laboratory to retake the battery of self-report surveys that they completed in the introductory session (Flourishing, Health, Authentic Happiness, PERMA Profiler) plus additional questionnaires (Interpersonal Support Evaluation, Inclusion of Other in the Self, Spirituality & Religiosity, Experiences in Close Relationships-Relationship Structure, Mindfulness, General Happiness). Compliance was high, with participants completing an average of 157 (SD = 15) of the surveys. Participants were paid proportional to their response rate.

On the first and last day, they completed basic measures of overall well-being, attachment, caregiving goals, and additional parenting specific measures.
